

Official Contest Rules

The Join the “Messina Hof’s Upcoming Events” Facebook Group contest (the “Giveaway”) is intended for play and participation in the State of Texas only and shall be construed and evaluated according to the laws of the State of Texas. Please do not enter if you do not reside in Texas.

1. NO PURCHASE NECESSARY. ODDS OF WINNING DO NOT CHANGE WITH PURCHASE. OPEN ONLY TO LEGAL RESIDENTS OF TEXAS WHO ARE TWENTY-ONE (21) YEARS OF AGE OR OLDER. VOID WHERE PROHIBITED.

3. TO ENTER: The Giveaway promotion begins at 12:01 AM CST on June 10th, 2009. Entries must be received by 11:59 PM CST July 10th, 2009. The administrator's computer is the official time keeping device for the Giveaway. This Giveaway will be administered by Messina Hof Winery and Resort (“Administrator”). The Administrator is not responsible for incorrect or inaccurate entry information or for late, lost, stolen, illegible, mutilated, delayed, misdirected, postage-due or incomplete entries.

Limitation for entries: Participants are limited to one (1) Giveaway entry per person. Finally, participants are limited to one (1) message per person/facebook account.
